## An Order For Child Support Has Been Established.

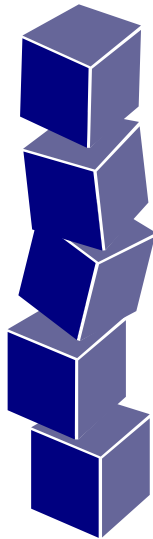
Your county Child Support Enforcement Unit will now begin enforcing the order.

You can play a **vital** role when you pay your child support. For example these positive things may happen....

Your child may appreciate the help that you give, which may strengthen your relationship with your child.

Your child may experience a sense of belonging, continuity, and increased self-esteem.

Your child's medical needs may be taken care of with the help of your health insurance or money provided by you. Your child could qualify for a number of benefits: Social Security, veterans benefits and life insurance.



## Paying Your Child Support

If you work regularly, an income assignment **will** be sent to your employer. The employer then deducts your child support from your paycheck and sends it directly to the Family Support Registry (FSR). However, if the employer does not deduct the full amount owed, it is **your responsibility** to ensure that your child support is paid each month. Making a partial payment is better than not making a payment.

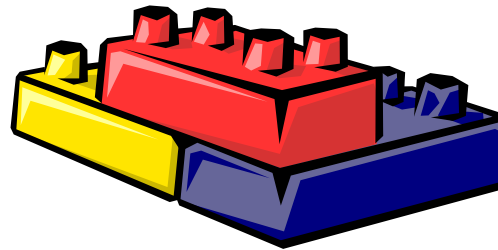

### Other Options

1. Regularly scheduled withdrawal from your bank account to the FSR.
2. FSR's **"Pay-by-Phone"** option.

## If You Fail to Pay Your Child Support

- ✓ You could be reported as delinquent to the credit bureau.
- ✓ Your professional, driver's, hunting or fishing licenses could be suspended.
- ✓ A contempt action may be filed against you. If you are found in contempt, the Court could impose a jail sentence.
- ✓ Your federal and Colorado tax refunds, your bank accounts, and your retirement funds could be automatically taken and applied towards the child support.
- ✓ A lien could be placed on your real or personal property or it could be seized to pay arrears.
- ✓ Your passport could be withheld.

### What If Things Change?

Any party may request a modification of the child support, if there is a significant change in financial circumstances, such as a parent's income or child related expenses (child care and medical expenses). Send your request **in writing** to your **county** Child Support Enforcement Unit, or file a motion to modify with the court.

**Keep your county Child Support Enforcement Unit informed of any change in address, phone number or employment.**
